MRS. BAUMANN WINS SUIT FOR HUSBAND'S INSURANCE

Awarded a Verdict in the Circuit Court Against the Metropolitan Insurance Co., for the Full Amount of the Policy and Six Per Cent Interest

A jury in the Circuit court gave Mrs. Frances M. Baumann a verdict of \$1,000 and 6 per cent interest, against the Metropolitan Insurance company this morning. The case was heard yesterday and a verdict was reached last night, but it was sealed and not opened until this morning. When opened it was found to be for \$1,000 and 6 per cent interest from October 16, 1908.

The husband of Mrs. Baumann was insured in the said company for \$1,000. The first premium was paid, but the second premium for alleged reasons was refused by the company and when Mr. Baumann died the company refused to pay the insurance and hence the suit.

The case of Bertha Goebel against Alexander Emmerich, for \$5,000 damages, is on trial in the Circuit court this afternoon. Both parties live in the town of Caledonia. The defendant was a farm hand and a minor. It is charged that he said things about the plaintiff that were slanderous and she sued for damages.

WAS IT KIDNAPING CASE?

Party of Italians Pick up a Three Year Old Child.

A great deal of excitement prevailed upon the north side just before noon today when it was rumored that the three year old daughter of Mr. and Mrs. Konick of 7th Geneva street, had been kidnaped. Mrs. Konick could not speak English, so very little could be learned when she was interviewed, but it was learned from outside parties that the child had been taken by a party of Italians while she was walking along the street and placed in a covered wagon. The party must have then driven down Douglas avenue, for a small child was thrown from a wagon on that street and eyewitnesses could not imagine what the trouble was and nothing could be learned from the girl because she could not talk English. Finally the mother or someone who knew the child happened along and took the child home. The matter was not reported to the police, but the circumstances are very suspicious, pointing towards a case of kidnaping.

ROADS SHOULD OWN LAND.
Reforestation Can be Accomplished by Railroads, Says Pinchot.
CHICAGO, Ill., Dec. 14.—The purchase of timber lands and their reforestation by the railroads of the United States was urged here today by Gifford Pinchot, chief forester of the department of agriculture. He was speaking at a conference of presidents and officials of the leading railroads of the country. Mr. Pinchot suggested the scheme as a means to preserve the resources of the country and at the same time provide railroad ties and posts for future use. In reply to suggestions made by Mr. Pinchot, President Mudge of the Chicago, Rock Island and Pacific declared in view of the possibility that within fifty years the railroads of the country might be under government ownership, the national government should provide for the future needs of the railroads. E. M. Griffith, forester of the state of Wisconsin told of the work that has been done in that state on cut over lands.

HAZEL DILLON IS DEAD.

Mystery Surrounding Girl Found in Lincoln Park, Unsolved.
CHICAGO, Ill., Dec. 14.—Hazel Robertson Dillon, the 18 year old girl who was found unconscious in Lincoln park, Dec. 1, died at a hospital here today. The death was reported to the coroner, who will make an investigation. The girl when discovered in the park gave several different stories to the police who were at first inclined to the belief that she had attempted to commit suicide. It was learned later, however, that she was suffering from hysteria.

U. S. GOVERNMENT FILES SUIT AGAINST POWER CO.
First Step Taken in Deep Waterways for a Lakes to the Gulf Highways Against Light & Power Co.
CHICAGO, Dec. 14.—The U. S. government has entered the controversy over the Dresden Heights dam of the Economy Light & Power company and the enormous water power rights claimed along the Desplains river near Chicago. In the federal court here, suit was filed today to enjoin the Economy Light & Power company from constructing the dam. A decree is asked to compel the restoration of the Desplains river to the condition existing before the building of the dam was begun.

INCREASE ARMY ESTIMATES.
House Committee on Military Affairs to Report Favorable Bill.
WASHINGTON, Dec. 14.—The estimates of expenditures of the war department for the coming year amounting to \$94,700,067, were favorably acted upon by the house committee on military affairs today, and the bill is ready to be reported to the house. The committee instead of making the customary reduction of departmental estimates increased several items and inserted one or two new ones, making a total increase of about \$1,000,000. The bill as completed will carry nearly \$96,000,000. Last year's military appropriation was \$100,450,083.

TAKE UP PRESIDENT'S MESSAGE
First Meeting of Ways and Means Committee Considers Recommendations
WASHINGTON, D. C., Dec. 14.—The president's message was taken up today by the house committee on ways and means. The meeting was the first held by the committee this season. There was considerable badinage between the Republican and Democratic members, regarding various provisions in the message, but the only action taken was to agree on the Payne resolution designating the committees to which different recommendations in the message should be referred.

IRISH NATIONALISTS MEET
DUBLIN, Ireland, Dec. 14.—The central committee of the Irish Nationalists at a meeting today decided to support the Liberals in the general election. Premier Asquith's recent declaration at Albert Hall concerning home rule for Ireland is deemed satisfactory.

The resolution to support the government was moved by John Redmond and was adopted unanimously.

GUILTY OF STEALING FUNDS.
UTICA, N. Y., Dec. 14.—Bernard L. French, former supervisor of the town of Whitesboro, pleaded guilty today to grand larceny of town funds. He was sentenced to not less than three nor more than six and a half years in Auburn. In all his shortage is alleged to be \$13,000.

CANAL INADVISABLE
WASHINGTON, D. C., Dec. 14.—In a report by the war department on the house today the \$8,000,000 project for a canal to connect Lake Superior and the Mississippi river by way of St. Louis is pronounced commercially inadvisable and inadvisable, though practically sound an engineering point of view.

CALL CHARACTER WITNESSES

Men of Standing Testify for Those Charged With Sugar Frauds.

NEW YORK, Dec. 14.—Men of standing called to the witness stand today gave certificates of good character to the six former employes of the American Sugar Refining company on trial for alleged conspiracy to defraud, and James E. Boardman, cashier of the Williamsburg plant of the company made a long statement in his own defense.

Boardman said that he had never had anything to do with the suborning or abetting of sugar. He did not remember ever paying out money to customs inspectors, he declared, although he frequently had to hand them out permits which were almost invariably closed in an envelope.

Boardman added that he had so made his subordinate statements, as it was impossible for him to investigate personally the taking of weights.

The West for Itself.
Los Angeles Times: The west has been too dependent upon the East in many ways. It was natural in the early development of the West that it should lean upon the richer communities on the Atlantic seaboard. There was not capital enough in the west to develop its resources, to build its roads or to establish life and fire insurance companies. But this is all changed. It is not many years since nearly all the crops of the west had to be moved by drafts on New York for money. This condition prevails no longer. The different great centers of population, and wealth in the west are taking care of their own affairs in nearly every way. This segregation into sections of the business and finances of the country extend very broadly. Not only is Chicago well supplied with money for the necessities of business and trade, but the same thing is true of Milwaukee, St. Paul, Omaha and even very much smaller cities than these.

Trout Market Ousted.
