

# GRAND RAPIDS IS DEFEATED BY 9-6 SCORE SATURDAY

## Contest on Local Grounds Proves Thriller of Historic Interest.

### SPIRIT IS FRIENDLY

#### Game is Close But High School Out-plays Rapids Team from the Start. Big Mass Meeting and Display of Fireworks is Feature.

Saturday brought forth one of the most sensational victories in the history of the High School. The Marshfield team defeated the Rapids by a score of 9 to 6. The victory was celebrated by a mass meeting around a huge bonfire on the campus, and a dance in the gym afterward. The team won a well deserved victory through their fight and determination to win, and the fact that they knew the student body was behind them. Friday night two hundred and fifty students accompanied by the High School band held a snake dance and mass meeting on Central avenue. This was the greatest demonstration of school spirit that Marshfield has ever seen; and due credit must be given to Coaches Parmenter and Scott for promoting such enthusiasm.

In spite of the disagreeable weather and the frozen field, the game was the best ever seen on the local campus and was witnessed by a fair-sized crowd. Marshfield played a great game, every man on the team working for all that was in him. Mention must be made of the stellar work of Capt. Whittlinger on defense—he was in every play and did much to keep his team fighting all the time. "Nut" McCarr ran the team like a general; his choice of plays was perfect; his open field running a feature; and his accurate passing kept the Rapids boys in constant fear. Doege was a "bear" on defense, spoiling many of the Rapids passes. Tice gave a pretty exhibition on the receiving end of the passes. Marsh kept his man busy all the time and outplayed his opponent by twenty yards on every exchange. Whittney and Goetz played a wonderful game, offensively, as well as on the defense. "Archie" Sean and his teammate Vaughn proved to be the downfall of the much touted McSwain. Reynolds gained ground consistently. "Ted" Hall played the best game of the year and was invaluable in instilling the "pep" in the fellows. Scheibe hit the opponents' line for good gains. Thiel and Heiser kept the game interesting after they got in. Carus kept the plays around his end, boxed in completely. The team completely outplayed the big red team for three full quarters. The locals had the ball in the Rapids' territory most of the time and the game was marked by splendid forward passing and line plunges.

#### FIRST QUARTER.

Marshfield received the kickoff and carried the ball to the thirty yard line. They went through for downs once but failed the second time. Both teams were working hard, but neither made any large gains. Reynolds tried two drop kicks, but missed both. The quarter ended with a score of 0 to 0.

#### SECOND QUARTER.

Grand Rapids had the ball on the thirty yard line and then made an end run of fifteen yards. In four downs they made their ten yards by a half inch. It was first down on the Marshfield one yard line and it took

three downs to put it across. This was the only time Grand Rapids got inside the Orange and Black twenty-yard line. Marshfield again received the kick off and carried the ball to the middle of the field. McCarr nearly made a touchdown on this play. With the aid of open plays Marshfield made large gains and carried the ball to the 10 yard line. With a few minutes to play Marshfield attempted to make a touchdown, but lost ten yards on a fumble. Fighting harder than ever to make up their loss they succeeded in getting the ball within nine yards of the goal but time was called. Score, Grand Rapids 6, Marshfield 0.

#### THIRD QUARTER.

This quarter was marked by the splendid forward passing on Marshfield's part. Marshfield kicked to Grand Rapids and scrimmaged on the forty yard line. Marshfield held for downs. Hall made a pretty run around the right end, carrying the ball to the twenty yard line. McCarr threw a forward pass to Tice, who was downed a few yards from the goal. After two downs McCarr pushed the ball through center for a touchdown. The goal kick struck one of the uprights. Marshfield kicked to Grand Rapids and received the ball after spoiling their forward passes. The quarter ended with the ball in possession of the Orange and Black. Score 6 to 6.

#### FOURTH QUARTER.

During this period Marshfield kept the ball in Grand Rapids territory all of the time. Marshfield used a series of spread plays, shifts and forward passes which carried the ball to the ten yard line. On the next play McCarr sneaked through center for a touchdown, but the head linesman blew his whistle because a Marshfield man was off-side. The fellows came right back and fought to put it across, but failed. Marshfield forced the Rapids to punt, and after a series of gains Capt. Whittlinger drop-kicked from the twenty yard line, and won the game for Marshfield. Time was soon called. Score 9 to 6.

The game was marked by good clean play on the part of both teams. McSwain put up the best game for the Rapids, while Grignon, their full-back, could not gain through our line. Stark put up a great battle on the defense. The local boys are mightily pleased to get back on friendly terms with the Rapids, and hope the good feeling now existing will be promoted by both schools.

#### ENLARGING ICE HOUSE.

## COMPARISON OF PRESIDENTIAL VOTES SHOWS FUSION HELPED REPUBLICANS IN MARSHFIELD

The following comparison of the presidential vote in the city of Marshfield this year with the vote in 1912 may be of interest. The tabulation of the votes polled by the different candidates during these two elections is as follows:

Some interesting conclusions may be drawn from these figures. For instance:

The total vote in 1916 was 1139. The total vote in 1912 was 1025. A gain of 113 votes. These 113 votes were Republican votes, or at least Hughes votes. Not all the Hughes votes were Republican votes perhaps, for it is generally known that many prominent Republicans voted for President Wilson and there may have been some defections among the Democrats which partially offset this. Wilson carried the city in 1912 over Roosevelt and Taft combined by 324 votes. The fusion of the Republican and Progressive forces this year reduced his plurality to 203 votes in the city, but the figures shown plainly mark a preference for the Democratic

candidate in both elections. President Wilson carried every ward in the city. The net "loss" if it may be called a loss, chargeable by the local Democrats to the agreement of the Republicans and Progressives to support one candidate, is accounted for within four votes by the increase in the fusion or Republican-Progressive vote. This rule did not hold good in California and certain other states where the result was close. Democratic leaders, while disappointed that the state and county tickets were defeated, are elated over the fact that Marshfield showed its presidential preference in an unmistakable manner. Some voted for President Wilson for one reason, others for another, but all of them for the purpose of helping him to be elected over Mr. Hughes.

### DO WE GET WHAT WE WANT?

May Peterson, Soprano, Says We Do. Ideas of the Singer Who Comes Here Tonight.

A few days ago an article appeared in the Columbus Dispatch which commented on the fact that only in encores does the public get what it really wants. The writer told of a soprano singer who thrilled and warbled through a difficult selection which received applause as acknowledgment of her ability. Then she sang beautifully and sweetly a song that had in it all the elements of tenderness, sympathy and even sadness. Naturally, the audience enjoyed the encore more than the first selection of the singer, but everybody in the audience would not be willing to admit as much, for fear it might be thought they really did not understand and appreciate the more classical renditions.

### THE WEATHER.

The weather man came upon us without warning leaving a cover of nearly four inches of snow most of which came Saturday and Sunday.
